#### **CONCEPTS & TERMS**

#### How would the speaker define policy, standard, and guidelines?

Start with the dictionary definition for terms. Next, really look at what you mean – a policy has to be around those things that your organization wants to see done consistently. Standard equates to those things for which you want standardization and repeatability. Textbook definition of a guideline is a document describing best practice which recommends what should be done. Compliance with a guideline is not normally enforced. Compliance to a policy and/or a standard should have governance.

# What percent of the time would you expect a process owner and a process manager to spend as part of their normal jobs?

A Process manager is focused on the day-to-day operation of that process. The manger's responsibilities include planning and coordination of all activities required to carry out, monitor and report on the process. When I was a process manager, I produced weekly reports on the status of my process and met with my IT Director monthly who was the process owner. This was a small IT shop, 70 people, so our IT Director was the owner of all our ITSM processes. In small organizations one person will wear multiple hats.

#### Are there any active or recommended ITIL forums out there?

Plenty. itSMF USA has Local Interest Groups (LIGs). They are unbelievable. Also many, many blogs. APMG has a lot of information on ITIL. Go to convention in San Francisco if you can.
